Gift Aid

We are an exempt charity. So if you pay Income Tax and/or Capital Gains Tax we would like you to treat your payment as a **Gift Aid Donation**. This allows us to reclaim 25p Gift Aid for every £1 you pay us.

- The tax year is from 6 April to 5 April. Your tax must be equal to or more than the Gift Aid reclaimed by all charities on your gifts for the year.

Please notify the society if

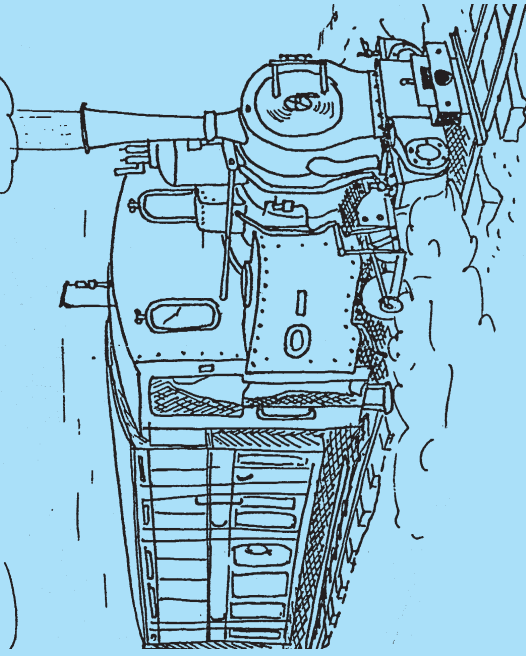
- you want to cancel your Gift Aid declaration, or
